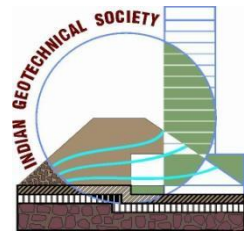

ITEM 0 WELCOME BY THE PRESIDENT

Dr. Anil Joseph, IGS President, welcomed the members to 65th Annual General Meeting at the scheduled time. However, the meeting was adjourned due to non-presence of quorum and was reconvened after a break of two minutes.

Dr. Anil Joseph, President, IGS thanked IGS-Roorkee Chapter for making all necessary arrangements for the meeting.

The General Body was informed that many IGS members passed away this year. The General Body observed a two minutes silence as a mark of respect.

The President welcomed the Past Presidents of IGS, Members of Executive Committee and Members of IGS to 65th AGM. Subsequently, the agenda items were taken up for discussion.

ITEM 1 CONFIRMATION OF THE MINUTES

The Minutes of 64th Annual General Meeting held on 15th December 2022 were circulated to the members as **Appendix-A** of the Agenda papers. No comments were received from the members. Prof. Mahendra Singh proposed to adopt the minutes, which was seconded by Er. Ramesh K. Kulkarni. The General Body approved the minutes.

ITEM 2 AUDITED ACCOUNTS FOR 2022-2023

The audited accounts of the Society for the period 01 April 2022 to 31 March 2023 were circulated to the members as **Appendix-B** of the Agenda

papers. The salient features of the audited accounts were presented to the General Body using a Power Point Presentation by the Honorary Secretary, Dr. A.P. Singh. He briefed the General Body on different heads of Accounts. Prof. Mahendra Singh proposed to adopt the accounts, which was seconded by Prof. N.K. Samadhiya. The General Body adopted the Audited Accounts for the year 2022-2023.

ITEM 3 REPORT OF THE HONORARY SECRETARY

The Annual Report of the Honorary Secretary for the period between 16th December 2022 to 31th December 2023 was circulated to the members as **Appendix-C** of the Agenda papers. The same was presented by the Honorary Secretary, Dr. A.P. Singh, during the meeting using a Power Point presentation. The members appreciated and adopted the activity report with a loud applause.

ITEM 4 ADDRESS BY THE PRESIDENT

ITEM 5 MODIFICATION IN ELECTION PROCESS AND CHANGE IN THE NUMBER OF CO-OPTED MEMBERS

Dr. A.P. Singh, Honorary Secretary, IGS informed AGM about the following proposal to modify the Election Process and Change the number of co-opted members. The proposal was earlier approved by the Executive Committee.

1. The Members shall vote for minimum 50% of the EC member positions (rounded to a higher integer).
2. The number of co-opted members shall be increased from existing 2 to up to 3. Co-opted members shall have one-year duration and shall be picked from unrepresented parts of India by the President. Thus, a maximum of up to 6 Co-opted members can be chosen during the two-

year duration of EC. A co-opted member shall be replaced if he does not attend two consecutive EC meetings.


Dr. Abhay Gupta raised a matter regarding above point 1. The item was deliberated at length by the members. Subsequently, the General Body approved the proposal.
